

Toi Mai National External Moderation Plan 2023

January 2023

Tēnā koutou katoa

Toi Mai Work Force Development Council is the standard setting body (SSB) for the culture, creative, recreation and technology sectors. Since 4 October 2021, Toi Mai has been responsible for National External Moderation, ensuring that all assessment is at a national level and meets the requirement of our unit standards. We strive to ensure that the standard is the same across the country, and that it meets the needs and requirements of our vibrant industries.

Transformation is a key driver for Toi Mai, and as we grow and collaborate, so too will national external moderation change. The external moderation plan for 2023 will be much the same as what you may be used to, but we will work with industry to identify how external moderation could look going forward.

Selection:

Moderation will be called in retrospectively, so assessed during 2022, all you need to do is take it off the shelf and send it to us either through the post or electronically. Please note that we will be moderating the 'Assessing Organisation' (this means that if you have had some other organisation assessing for you, then we will be moderating them, even though you may have reported the actual unit standard/s to NZQA). We have initially selected 204 unit standards to be moderated during 2023. Once we have received the Quarter four NZQA report, then more unit standards may be added. Some of the considerations taken when selecting the unit standards were high usage, high risk and new unit standards, and also coverage of all domains. Please note that when selecting the unit standards, 50 of the high reporting unit standards from the 2022 plan were re-selected.

Process:

- In early February 2023, we will email <u>all</u> organisations and outline which unit standards have been selected for your organisation and when the moderation will be due.
- Then four weeks before the due date you will receive a second email.
- Moderation sample selection will usually range from two to six unit standards, depending on assessing/reporting activity. High reporting will mean more unit standards will be called.
- Please send in three Candidate Assessment samples for each unit standard (where possible we would like to see a mix of competent, not yet competent, and borderline assessments).
- Please also send in an Assessment Schedule (including judgement statements and model answers) for each unit standard. You will need to confirm whether your assessment material has been pre-moderated and approved by Toi Mai or one of the former Industry Training Organisations.
- Complete the Post Moderation cover sheet and submit either through the post or email it to us. The Post Moderation cover sheet can be found here: Post-assessment-moderation-coversheet-Toi-Mai-2.pdf (toimai.nz)

School moderation forums/cluster group Moderation meetings:

We are looking to host these during the 3rd Quarter. We are still identifying the areas where these could be most useful, it is something that we would like to do more of in the future. Schools that do attend one of these events will then not be required to submit postal moderation.

Work Based Learning Organisations (WBL's):

We are aware that Work Based Learning Organisations (former ITO's/TITO's) use a national assessor model for assessment, and that assessments are not stored in one place. WBL's also have high reporting activity, thus we have decided to handle this moderation differently as follows:

 Please understand that due to WBL's high reporting and the need for us to ensure that all domains are covered over a five year moderation cycle, we are obligated to request a higher volume of moderation from these organisations. This also means we may require more than the standard three samples per unit standard.

Online portal for moderation submissions

Progress is underway for a provider portal, so that schools and providers can submit their post moderation assessment samples online. The portal is currently in the testing phase and is expected to be up and running in Quarter 2 (April 2023). Providers/schools will be given a login and instructions to access their moderation request online. From here, you will be able to access the moderation request, submit samples and update moderation contact details.

For 2023, our preference is that online samples are submitted, however, you will be given the option to select 'postal/courier' if you would prefer to send in hard copy assessment samples.
