

Kia ora koutou

As you may be aware, Toi Mai Workforce development Council is now the standard setting body for Hairdressing, Barbering and Salon Skills and we are responsible for National External Moderation. Our role and function is quite different from the role that HITO had, and the purpose of this communication is to inform you of some of the changes that may affect you.

Assessor numbers:

Toi Mai will not be issuing Assessor/Tutor numbers as has been the practice in the past. Each Provider is responsible for ensuring that all their staff are suitably qualified and experienced and participating in professional development. Providers are encouraged to study CMR: 020 to familiarize themselves with the requirements. The Quality Assurance team will be checking the appropriateness of assessors during site visits and other moderation activities. Please contact us if you need any guidance in this regard.

Post Moderation:

The National External Moderation Plan for 2022 can be found [here](#). Moderation will be called in during the 3rd and 4th quarters for all providers regardless of previous moderation status. Site visits will be conducted during this period too and we will notify you at least six weeks in advance. Moderation will be called in retrospectively, so assessed in 2021. Two to six unit standards will be called in depending on provider activity. During 2022 we will consult with you to develop a new moderation system from 2023 onwards.

Pre-Moderation:

Please ensure that all assessments that are being used have been pre-moderated and approved, either by HITO or by Toi Mai. Please note that you will need to provide a pre-moderation report when submitting your post moderation samples.

Consent and Moderation Requirements (#020):

Toi Mai will be working with NZQA to update and review CMR 020 during 2022. We will also be asking for input from industry and providers. All Toi Mai's CMR's will be combined into one comprehensive CMR with an appendix for each industry. Please use CMR 020 as is in the meantime and contact us if you need any clarity. We understand that this is not ideal but please bear with us and we continue to merge our sectors under one Council. The good news is that the WDC's will not be charging for Consent to Assess, Pre-moderation or Site Visits.

Hairdressing and Salon Skills standards review:

Toi Mai is progressing a review of 46 Hairdressing and Salon Skills unit standards started by HITO. There will be opportunities during February to give us your thoughts on draft new and reviewed standards.
