The advice received for investment in and from 2026 was thorough and well informed.

In recognition of the maturity level of the advice function and the pressure on resources in WDCs for the rest of 2025, we have set up a simple process for advice which draws heavily on the work done last year.

We expect that with the time it takes to make shifts in the tertiary education system that your priorities for investment are likely to be quite similar year-on-year.

For investment in 2027 we are asking you to:

- (a) Review the advice from last year and advise us of any changes
- (b) Advise us of any new items of advice that have become apparent through workforce analysis.

New Zealand Certificate in Information Technology Practitioner (Level 6) with strands* [Ref:2599] *Note as part of the review of all vocational IT qualifications, this certificate has been updated, and the changes have been submitted to NZQA. As a result of the changes, the qualification has been renamed "New Zealand Certificate in Applied Digital Technology" (Level 6), expanded to 60 credits (from 40) and will be assigned a new qualification number, which is pending. This qualification is designed to provide specific focus on industry-aligned software, languages and products, including AI, and be flexible to include emerging industry trends that happen in information technology.	Provider-based	All regions	Increase	According to AI Forum New Zealand (2025), AI adoption in New Zealand surged in 2025, with 82–87% of businesses and 69% of consumers using AI tools to enhance productivity. This growth highlights an increasing reliance on AI across sectors, alongside a rapidly evolving demand for AI-related skills. MBIE's latest paper on New Zealand's AI strategy and Datacom's 2024 State of AI Index both identify skills shortages as the main barrier: 43% of non-users cited lack of expertise as the primary reason for not adopting AI. This qualification, focused on updating specialist IT skills in areas such as Server Administration, Network Administration, IT Security and Software Testing addresses this gap by equipping professionals to implement and manage AI systems effectively, ensuring New Zealand's digital workforce can leverage AI to boost productivity.

New Zealand Diploma in Information Technology (Level 5)** [Ref: 2596] ** Note as part of the review of all vocational IT qualifications, we have expired several level 5 IT diplomas and created strands Infrastructure and Technical Support, Software Development and Applied Digital Technologies, and renamed this diploma (it was previously New Zealand Diploma in Information Technology Technical Support).	Provider-based	All regions	Increase	Al New Zealand (2025) highlights that New Zealand's digital technology sector is undergoing a major transformation, with Al adoption reaching 82–87% among businesses and 69% among consumers. However, Al Forum (2025) notes a persistent skills gap, as only 41% of the workforce currently utilises Al tools, despite 81% of businesses supporting Al training for staff. This qualification addresses that gap by equipping graduates with essential skills in IT infrastructure, cybersecurity, database management and software development – critical areas for effective Al integration and operation. As such, the programme prepares professionals to meet the evolving demands of New Zealand's Al-driven digital economy.

Toi Mai remains concerned that low funding levels for micro-credentials creates a disincentive for providers to offer them. This creates challenges for many working in the CCRT sectors as shorter, work-based courses are often more relevant than the longer courses providers tend to offer.

This is also true of programmes such as Piano Tuning for which small cohorts are desired by industry. Under the current business model, programmes with small cohorts are undesirable to providers and as a consequence are not available for learners. This threatens the viability of the performing arts sector – festivals, productions and concerts – in that without skilled piano tuners available in Aotearoa, piano tuners have to be brought in from overseas at significantly higher costs.
